Dear All,

Following consideration of a situation that may impact on Representative Players ability to play CNW Club games, the CNW Board has made the following adjustment to the CNW Rules Handbook Senior Competitions 2024/25:

Rule 52 – additional point (f) – Unexpected Representative Player - Replacement:

*If a player is returning to their Club from representative duties, but is not listed as a replacement player on the team sheet, the player may only play in a CNW match subject to a written request to the CNW Board and on receiving the approval of the CNW Board. Any approval would be conditional on the replacement being like for like. **The clause is only appropriate when the return of the player is unknown at the time of the toss.** In this circumstance only the CNW Board can approve the replacement; the opposition captain cannot approve. Both the opposition Captain and the Umpires should be advised of the replacement. The replaced player may play in a lower Grade subject to same requirements as indicated above, i.e. CNW approval and consideration of a like for like replacement.*

We ask that you forward this information to appropriate individuals within your Club, including, but not limited to your Club Coach, and 1st & 2nd Grade Captains.
